Our main goal is to consistently exceed your expectations and provide unparalleled golfing experiences. Starting January 1st, 2024, we will be adjusting our fees. Rest assured, these changes have been carefully considered and are necessary for the successful operation and ongoing improvement of our club. We understand that changes to fees can be a sensitive topic. We made the decision to modify our fees based on an extensive evaluation of factors such as rising operational costs, necessary maintenance, and essential facility improvements. The men's changing room and restaurant washrooms will undergo meticulous touch-up work in the coming months. Please note that the Privilege Quota arrangement will remain unchanged in 2024. Each membership can enjoy 12 quotas with the 18-hole green fee of \$1,250 in 2024.

We sincerely appreciate your understanding and cooperation during this transitional period. Your unwavering supports are unequivocally valuable to us, and we eagerly anticipate another outstanding year together, filled with remarkable moments of golfing excellence.
